2. The work is to be completed within the specified period mentioned on the first written work order.
3. Firms / Contractors are required to submit their applications for issuance of tender documents alongwith their complete credentials as shown at (Serial 4). The applications shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors. The tender must be received back in the office of **GE (A) PMA Kakul** by 1130 hrs on **28th February 2019** and will be opened at 1200 hrs on the same date and same place.
4. Firms / Contractors born on approved List of MES in Categories 'A', 'B', 'C', 'D' & 'E', having experience of this type of work should only apply. Firms / Contractors not borne on approved list of MES will furnish a certificate alongwith their applications, giving details of works executed during last two years and those in hand on the proforma appended below:-

5. Contractors / Firms not enlisted with "MES" shall deposit Rs 500/- as tender fee and 2% amount of estimated cost of work as earnest money (refundable).
6. If tender of a Contractor / Firm not enlisted with MES is accepted he shall be required to deposit Rs 25,000/- as security in the form as demanded by accepting officer.
7. **GE (Army) PMA Kakul** shall be the accepting officer and is referred to as such for the purpose of the contract.
8. Firms / Contractor will certify in writing that they are registered with PEC (Pakistan Engineering Council) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.
9. Firm / Contractor shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ Rawalpindi) is outstanding against them.
10. Contractors who desire may be present at the time of opening of tenders.
11. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
