- 4. Contractor born on approved list of MES in category 'C' & 'D' and also having experience of this type should only apply. If tender of a contractor not enlisted with MES is accepted he shall be required to, deposit Rs. 2% as security in the form as demanded by accepting officer.
- 5. Contractors who desire may be present at the time of opening of tenders.
- 6. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per para 33 (i) of PPRA Rules.
